Ignite NC empowers youth ages 18-25 to lead issue-based campaigns in their communities that build a more fair and just future. The Ignite NC fellowship program provides organizing skills, mentorship, and collaboration opportunities to help develop young people into community leaders. Ignite NC trained 39 fellows across 9 campuses in 2015.

4b (Code) (Expenses \$ 93,530 including grants of \$) (Revenue \$ 650)
Youth Organizing Institute is a leadership development program working with youth ages 13-20 who are impacted by education justice issues. Students are trained on concrete organizing skills, connect with intergenerational activists, and learn from other young community organizers. Students in the program lead campaigns that support long lasting positive social change. The program held 2 week-long Freedom School sessions in Durham and Wake Counties, training approximately 55 students from North Carolina.

The Education Justice Alliance is a group of concerned individuals in Wake County working for a reduction in the number of public school students pushed off the academic track through unfair suspensions, harsh discipline policies, and academic failure. The parents in this group, attended approximately 32 school board or committee meetings in Wake County.
