In its fifth year, OurSpace World Inc (dba OurSpace Acupuncture) has continued to provide community acupuncture services, providing 4,724 treatments (548 new client visits, and 4,176 returning client visits). Of these, 279 (up from 180 in 2014) were treatments given for free or for a subsidized amount (below our suggested \$15-\$40 donation range). In total, we provided 1,093 more treatments than in 2014. In May of 2015, OurSpace expanded its availability and is now open seven days per week (up from five days per week in 2014), with two treating acupuncturists. For a portion of 2015, OurSpace employed administrative staff and also utilized a number of unpaid volunteers and interns.

In 2015, OurSpace started a Sustainable Food Project by partnering with the Lancaster Farm Fresh Cooperative, a non-profit organic farmer’s cooperative of over 100 family farmers headquartered in Lancaster County, Pennsylvania. Managed and staffed entirely by volunteers, OurSpace became a host / pickup site for fresh, organic produce in the form of CSA (community-supported agriculture) shares. A total of 42 households picked up weekly vegetables and fruits from May through November over two seasons.
