The review includes several components - input from the board members and key stakeholder partners regarding the ED's performance, interviews with staff members, and a written self evaluation by the ED. Once this process is completed, the Board Chair recommends to the Executive Committee a salary level for the ED for the next year, within the budget established by the Board. The Executive Committee reviews and votes on the performance review and recommended salary level for the ED.
