The purpose of the Morristown-Hamblen Hospital Foundation is to support the Morristown-Hamblen Healthcare System in promoting and advancing the well-being of the community by providing quality healthcare and health-related services. The Foundation provides philanthropic support to the Morristown-Hamblen Healthcare System through the generosity of individuals, corporations, and foundations in the community and supports the hospital's mission "to serve the community by improving the quality of life through better health."

Neuro Robot for MHHS Emergency Room. Morristown-Hamblen Hospital Foundation provided a Neuro Robot for use in the Morristown-Hamblen Hospital Emergency Room. Assisted by a nurse, neurologists can provide whole patient assessments via a remote satellite link. The neurologists are available 24 hours a day, 7 days a week to help make critical, time-sensitive decisions in the ER. The Neuro Robot allows patients to be treated locally instead of transferring to a facility further away. Thirty-five patients benefited from the use of the robot in 2015.

4b (Code) (Expenses \$ 6,497 including grants of \$ 6,497) (Revenue \$)
Patient and Employee Emergency Assistance. Contributions from the annual employee giving campaign support the assistance fund at Morristown-Hamblen Healthcare System which provides emergency assistance for patients and employees in times of crisis. In 2015 the funds assisted 11 employees with emergency aid for items such as food, housing, transportation, medications, medical equipment and funeral expenses. Six cancer center patients were provided gas cards for transportation to and from treatment, and special skin cream for radiation treatment side effects and other supplies were distributed to patients in need.

Staff Education. Funds were used to support continuing education for Morristown-Hamblen Healthcare System employees, including respiratory therapy certifications, linear accelerator advanced training, and chemotherapy and biotherapy certification for oncology services staff.
