This program is a partnership with the City of Memphis and its purpose is to provide minor home repair services to low and moderate income families, senior citizens, and individuals with disabilities. Participants are not charged for these services. RepairWorks is specifically dedicated to addressing critical needs and focuses on severe trouble areas such as leaking roofs, plumbing, heating and cooling, and electrical issues.

SOUTH MEMPHIS FARMERS MARKET/GROCER

This program seeks to bring high quality, moderately priced fruits, vegetables, and other food products to the residents of South Memphis. This market serves over 10,000 low and moderate income individuals. The community does not have a major grocery store or food outlet and accordingly, may be labeled as a food desert. Without this market, residents would have to go to great lengths just to obtain affordable nutritious food product.

The South Memphis Revitalization Plan

This is a community based action program designed to mobilize community residents, institutions, and other stakeholders to implement comprehensive economic and community development programs. Approximately 500 residents are served by this program.
