The Foundation creates Bright Spaces specialized play rooms in homeless shelters designed to serve the shelter-specific population. To date, over 260 Bright Spaces are open around the US, serving approximately 83,000 children annually. The Foundation sponsors regular volunteer activities in the Bright Spaces to include playtime, enriching programs for children and families, infant care training for new mothers, and college application assistance to young adults. The Foundation gives grants to community organizations supported by employees of Bright Horizons Family Solutions.
