

The Organization provides various food supplies to member organizations. The member organizations are unrelated to the Organization. The method used to determine the book value of the contributed food distributed is a weighted average wholesale price per pound as determined by Feeding America. The value as of and for the year ended December 31, 2015 was \$1.70 a pound. The total amount of contributed food distributed amounted to \$27,481,934 to 600 501 (c)3 member agencies.

The Organization distributes food in Alabama, Mississippi, and Florida. The Organization has contracts with the U.S. Department of Agriculture which is passed through from the various State Agencies. Each contract has requirements regarding the member agencies that may participate. The requirements, including among other things, maintaining complete and accurate records to document the receipt, disposal, and inventory of commodities. Member organizations must insure that food is distributed only to households who are eligible as determined in accordance with State Eligibility Criteria. Monitoring the use of grant funds is performed by internal audits of member organizations performed by the Organization as well as audits performed on the Organization and member organizations by State Agencies.


