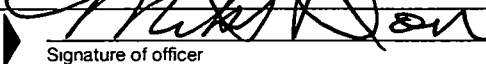

the Board of Directors electronically for their review prior to the return being filed.

Form 990, Part VI, Line 12c - The Organization, on an annual basis, asks each member of

not have any conflicts of interest with the Organization.

Form 990, Part VI, Line 15a - The compensation of the Executive Director was reviewed by
