PRIOR TO THE RACE WEEKEND VOLUNTEERS ARE RECRUITED FROM THE GENERAL PUBLIC TO SERVE AS CREW MEMBERS FOR THE BALLOONS THAT COME FOR THE RACE. THESE VOLUNTEERS ARE PROVIDED CREW TRAINING PRIOR TO THE RACE WEEKEND. THE GREAT MISSISSIPPI RIVER BALLOON RACE IS ADVERTISED THROUGHOUT THE SOUTH AND THIS ADVERTISING PROMOTES TOURISM IN MISSISSIPPI AND NATCHEZ. THE RACE HAS RECEIVED NATIONWIDE RECOGNITION IN SOME TRAVEL AND LEISURE PUBLICATIONS AND THIS NATIONAL EXPOSURE HAS BENEFITED THE CITY OF NATCHEZ AND ITS CITIZENS.
