Program-1 Workshops and Roundtables - TRACE held workshops in Manila (48 attendees) and Mexico City (78 attendees) for the employees and intermediaries of TRACE member companies These workshops provided international compliance best practices and addressed local anti-bribery laws and enforcement trends, as well as the nuances of the US Foreign Corrupt Practices Act Speakers included senior compliance executives from TRACE member companies, partner firm representatives and local government officials Such workshops are free for TRACE Members to attend Roundtables were held in Chicago (8 attendees), Copenhagen (13 attendees), Melbourne (11 attendees), Paris (14 attendees), Ethiopia (2 attendees) and Sydney (11 attendees) These roundtables facilitated benchmarking among TRACE member companies Topics focused on the priorities and concerns of each participant and the discussions were led by a senior TRACE attorney or Alexandra Wrage TRACE also hosted a trip to Cuba to help TRACE Member companies interested in doing business in Cuba navigate the regulatory landscape 9 member company representatives attended The trip included business meetings with local organizations and law firms, as well as a workshop led by TRACE to discuss compliance challenges

Program-2 Online Training - TRACE provides unlimited online anti-bribery, human trafficking awareness, conflicts of interest and conflict minerals training to employees and third party intermediaries of member companies These highly acclaimed modules are available in up to 18 languages, with additional languages available upon request Using real-life scenarios and cases, the training modules offer TRACE member companies a low cost and practical way to effectively train a large number of employees and intermediaries on compliance requirements Two distinct anti-bribery modules offer targeted training for employees and intermediaries The human trafficking awareness module is the first-ever training designed for the business community Training modules provide best practices based on internationally accepted norms Additional training modules on other compliance topics are currently under development
