Through the branded radio network of Freedom Radio FM which consists of broadcast facilities and FM stations across the country as well as internationally via the internet, Edgewater Broadcasting brought to listeners a balance of solid biblical teaching, live talk programming, soft adult contemporary Christian music. In addition to this helpful and educational format, EBN aired local announcements featuring community churches, non-profit organizations and public service announcements. EBN also launched a contemporary Christian music format, FreeFM. This format serves multiple markets across the country and provides a 24 hour music service to those communities not served or underserved by a Christian music format. FreeFM provided spots to church groups, community groups and not-for-profit organizations at no cost. FreeFM is also available worldwide via the internet at freefm.org.
