The Basic Field Grant is the major entity's fund that provides legal assistance in non-criminal proceedings for qualifying financial disadvantaged program participants. Some of the proceedings covered are family law, domestic violence, employment, special education, health, housing law, juveniles, consumer rights, environment law, migrant farm worker rights and community development. The basic program worked on approximately 21,840 cases for low income families during the year.

4b (Code:) (Expenses \$ 1,390,886 including grants of \$) (Revenue \$)
The legal services corporation requires that Puerto Rico Legal Services, Inc. (PRLS) designate a minimum of 12.50% of its annual funding to private attorney involvement efforts, encouraging attorneys in private practice to provide free legal assistance to indigent individuals and communities. The funding to private attorneys during the year provided services in approximately of 9,319 cases for low income families.

Legal assistance is provided to migrant farm workers in the priority areas listed (4.a). During the year the organization provided services in 27 migrant worker cases, representing dozens of workers.
