Assisted Living - Licensed by the State of California as a Residential Care Facility for the Elderly, the assisted living facilities provide 24 hour care and supervision in a residential environment. Memory Care - Opened in May 2014, Licensed by the State of California Facility to provide 24 hour memory support services for those who have age-related dementia or Alzheimer's diseases, A-Day-Away - Opened in May 2014, Licensed by the State of California Facility to provide a safe, engaging place for loved ones for a few hours or even a full day.

Skilled Nursing - Licensed by the California Dept of Public Health and certified by the Federal government for participation in Medicare. Extensive in-patient and out-patient therapies provided in order to return residents to their home or allow them to be as independent as possible.


















