If it were to consider hiring one, the salary would be reviewed by members of the board pursuant to IRS rules and regulations. Efforts would be made to secure data from industry sources to determine the competitiveness and appropriateness of the proposed salary to similar public benefit organizations. Every effort would be made to ensure that this process is thorough and transparent.
