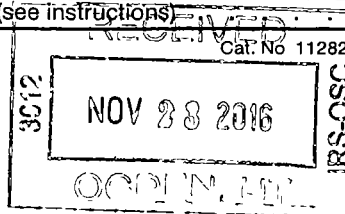

In 2014, after a well-publicized community meeting, and independently acquiring other community input, two things became apparent to AVEH: the immediate need for our senior community is for affordable independent living units close to town, and our planned assisted living facility is no longer an immediate dominant community need. In addition, it has become clear that financing an assisted living facility is not an attainable goal for a small non-profit organization in a rural community. With that in mind, AVEH refocused its energies on providing independent living units. We remodeled and upgraded our duplex. We finalized all the upgrades on the property where future expansion will occur. A local senior is currently leasing the house. Research continues on the feasibility of various plans for the small, independent housing units to be built.
