Our mission is to support sustainable agriculture and resource protection in the North Coast. We have four major project areas:

(a) "Bee Patches" pollinator habitat protection to increase biodiversity and improve agricultural sustainability for pollinated crops;

(b) "Rain Catchers" water conservation program, (c) "Vermiculture Waste-to-Compost" for reducing landfilling of food waste, and

(d) "Cultivating Commerce" for new or expanded sustainable agricultural entrepreneurship.

Rain Catchers - Watershed Scale: Administered Fisheries Restoration Projects in Salmon Creek and Dutch Bill Creek within the Gold Ridge Resource Conservation District. These water conservation and habitat restoration projects eliminated large pumps in the creek which affect low flow periods, and began utilizing off stream storage. Most field work was completed in 2015, with a small amount of work continuing in 2016, and monitoring continuing through 2018. Our direct subcontractor was Gold Ridge Resource Conservation District which received \$692,966 for contractor services in these projects.

Bee Patches Pollinator Habitat Plantings: Six girl scout troops worked with five agricultural landowners in the design and planting of pollinator habitat patches on their lands, meeting criteria for forage, seasonal flowering, water, and nesting. All non grant expenses were program related (plants, soil, irrigation, seed, etc.) and all staff time was volunteer.

Rain Catchers in Your School: A \$4000 grant was received in 2015, but no funds were expended until 2016. Volunteer time was expended to locate two schools in underserved communities, and to plant the design and construction of two rooftop rainwater collection and storage systems. The "Build It" day and all program expense would not occur until 2016.
