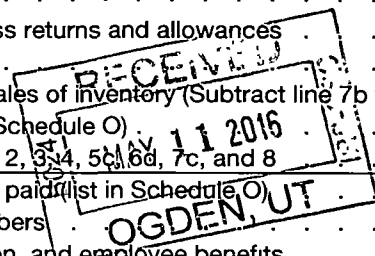

The Lost Children Foundation (LCF), Inc. uses the calendar year: January 1 -December 31. LCF received its exempt status February 11, 2013 retroactive to October 26, 2012 with two months remaining in the calendar year. A contribution in the amount of \$35,939 was donated prior the year to fund programs in 2013. Calendar year 2012 is considered a "short year" of two months and is included in the five year calculation for public support since the contribution occurred in 2012.

**Part II. Section A, 3. Donated Facilities**

Two of the Lost Children Foundation programs are held in facilities that are provided without charge. Personal training for seniors living in two low-income residential facilities takes place year round from January through December. The value of donated facilities is consistent with the market value that would ordinarily be charged to the public. Training space is provided four days a week.

Additionally, LCF supports an after school program, three days weekly for three hours daily. Four rooms are provided without charge.

The after school program operates ten months from September through June of each academic year.

**Part 1: Line # 10: Grants and Similar Amounts Paid**

A scholarship in the amount of \$1,931 to cover the balance owed for fees, books, and tuition, and a required laptop computer, cost: \$1,589 was provided through the Lost Children Foundation Post-Secondary Continuing Education program to a first year student entering a four-year institution majoring in biology. Total financial support: \$3,520.

**Part II: Balance Sheet, Lines 24 and 25, Other Assets and Total Assets :** Other assets include contributions received during the year in the amount of \$33,299 plus \$12,104, cash on hand at the beginning of 2015, totals \$45,403 in Total Assets.

**Part III: Statement of Program Service and Accomplishments, Line 28.**

During 2015, 606 sessions were provided to twelve older adults ranging in age from their mid-fifties to mid eighties, the majority of whom reside in low-income residential housing. Personal fitness training takes place in two residential facilities and in clients' homes. While a few clients are in their sixties, the majority are in their 70s and 80s and use ambulatory devices (walkers, canes, and wheelchairs) for mobility. The oldest participant is 87 years of age. Sessions are generally 45 minutes to an hour and are scheduled minimally twice a week with some clients training 3 days weekly. Build A Better You (BABY), the LCF resistance training program, is designed specifically for seniors to enhance healthy aging. In 2015, BABY provided over six hundred hours of training to 12 participants two to three times a week, plus four weekly workshops during the month of May in commemoration of Older American month.

**Part III: Statement of Program Service and Accomplishments, Line 29.**

Post-Secondary Continuing Education (PSCE) provides scholarship awards to academically talented students, specifically African American males, who have demonstrated academic potential and who have enrolled in a four-year college or university. \$3,520 was awarded to a student majoring in biology. PSCE provided financial support to one student. We expect to expand scholarship support in the future.

**Part III: Statement of Program Service and Accomplishments, Line 30.**

Literacy Plus is an all volunteer program. Space is donated that houses an after school program three days weekly, for 2.5 hours, from September through June. There are 19 participants that include 4 teachers and 15 students in K-6 grade. Additionally, individualized 1-to-1 reading and writing instruction is available during the summer. 300 hours of service is provided over the ten-month period. The three service programs described in Schedule "O" fulfill the mission of the Lost Children Foundation to help children, young adults and seniors in providing educational services for children, funding to help academically talented young people continue their education beyond high school, and seniors, who do not have the means to pay for personalized fitness training and a personal training coach.

The Board of Directors of the Lost Children Foundation is a voluntary board comprised of eight volunteers. Two members of the Board reside in Michigan, and the remainder reside in Pennsylvania. Officers and/or members are not compensated.

The organization has no employees, and professional services are contracted out to independent contractors, as needed.

Compensation for one independent contractor in 2015 was less than \$35,000, well under the market value for the quality and quantity of service provided.

Dr. Beatrice Mickey, the Pennsylvania Program Officer and secretary, manages the daily operations relative to programs in Pennsylvania. The position is part-time and voluntary.
