Most of all, they find healing through the love of Jesus Christ. For small time pastors, The Water Tower Network's ranch is a place of training, refuge, and healing. It serves as a free-of-charge bed-and-breakfast where ministers have access to intensive counseling and healing from burnout or heartbreak due to the challenges of small town and rural church ministry. They will be able to return to their ministries recharged and refreshed.
