These grants were awarded to fund the development of potential therapies for Duchenne Muscular Dystrophy utilizing strategies designed to repair the genetic flaw of this catastrophic, single-gene-defect disorder, support academic research institutions in efforts to bring therapies to the marketplace that would compensate for the lack of a protein essential in muscle regeneration and repair, and fund scientific workshops for leading muscle researchers and clinicians to effectively collaborate on strategies for translation approaches to muscular dystrophy.
