Energy Efficiency Programs: Conducted door-to-door outreach signing residents up for free: energy audits, recycling, trees and resources. We completed about 212 home energy audits in Denver and Commerce city. Low-cost and major energy upgrades, such as insulation or energy efficient appliances, were installed in many of these homes.

Green Team Youth Employment Program: GWD employed 59 youths who worked in urban gardens and on neighborhood improvement and civic engagement projects related to environmental issues as well as healthy eating and active living. The ages ranged from 13 to 22. The older youth (18-22), worked at Rocky Mountain Arsenal National Wildlife Refuge and other public lands. The youth age 14-17 worked on community projects, including urban farming and water quality. The youngest students (13-14) worked on a variety of projects, mentored by the older youth.

Transportation Demand Management Project: Provided individualized alternative transportation resources and promoted Smartphone resources for households in west Denver to mitigate vehicular congestion and pollution.
