2015 AITo Program Service Accomplishments In 2015 the Alliance for Tompotika Conservation (AITo) continued its work working with local villages on the Tompotika Peninsula in Sulawesi, Indonesia conserving endangered birds, bats, and turtles. Conservation efforts have begun to show very positive results, with the Maleo bird population at a new record high at one nesting ground. In addition, the organization provided fire-fighting support for unprecedented forest fires in the area and initiated a childrens library book project to purchase and translate quality childrens books for local schools. In the early part of the year AITo produced the first Tompotika International Maleo and Sea Turtle Festival in six different villages as part of our Art in Conservation outreach program.
