There is, or may be, an underdistribution, which may be the result of clerical error. There is the likelihood that we are unable to accurately interpret the applicability and intended results of including invested funds as non-exempt-use assets. If we are required to distribute 3.5% annually of our only asset, the fund will be liquidated over a relatively short period. Our treatment of the endowment fund as a non-exempt-use asset may not be correct, based on a logical conclusion that the original donor's intent that all interest earnings be used by the supported organization would not cause the fund's principal to be so decimated during extended periods of low interest rates. We request a determination that the invested funds be excluded from the definition of non-exempt-use assets.
