The Fund had excess receipts in excess of \$200,000 and filed Form 990 for the year 2014. An adjustment on Line 5, Part XI in the amount of \$26,304 converted the carrying value of its investment portfolio from cost basis to market value at December 31, 2014. The adjustment on Line 20 returns the fund balance to a cost basis.

Part III

The Fund, under the terms of the trust instruments that created it, distributes its investment income to Loyola University, New Orleans, for the sole purpose of maintaining, renovating, improving and/or repairing the church building located on the campus of the University known as Holy Name of Jesus Church.
