THE COUNCIL, THROUGH OPERATIONS THAT ARE TOTALLY NON-PROFIT, CONDUCTS EDUCATIONAL SEMINARS IN INDUSTRIAL SAFETY FOR CONSTRUCTION AND FOR PETRO-CHEMICAL WORKERS. MOST OF THE LARGE REFINERIES IN THE AREA REQUIRE PROOF (AN ID CARD) OF SUCCESSFUL COMPLETION OF THE COUNCIL'S ONE-DAY SEMINAR. THE REFINERIES OFTEN PROCESS THEIR OWN EMPLOYEES THROUGH THE COURSE, OR OFFER SIMILAR IN-HOUSE TRAINING.
