Gateway Ministries has a board of director administration composed fully of Indian citizens. The grant of \$119,000 was approved by the US Board of Directors of Gateway International and the receipt of this gift was approved by the Gateway Ministries Board of Directors for the future purchase of land to conduct this charitable operation inside the country of India

Gateway International does not have direct control over the governing actions by this Indian non profit organization, however a presence of direction is provided by two board members who interact with Gateway Ministries on behalf of Gateway International

Gateway International does conduct charitable activities for children and young women at both a Children's home and a community college free of charge for the residents.

Gateway International continued in 2015 its' educational projects which included over 50 students under the care of the organization

There were 30 boarding children at the Gandhi Nagar Leper colony in Gulbarga, Karnataka. There are several children which are home schooled at Gateway boarding school in R.T.Nagar, Bangalore. Several others attend a boys school and girls school. In addition, there are students which come from evening tutoring sessions. (Form 990 Part III Line 4A, program accomplishments \$104,793)

In 2015, Gateway Church averaged in excess of 90 people for Sunday morning services with 75 children and youth. Services were generally in English with Kannada interpreters. Every Sunday, the ministry provides a meal for all who come. The Gateway Education facility in Kyalasanahalli Village, Bangalore, has been in service since January 2012. The Gateway community college program is a two-year certificate program. The students are taught the following secular courses; teachers training, community health and hygiene, typing, computers, counseling, leadership skills, spoken and written Kannada as well as English, cooking, tailoring, baking, and gardening. These courses will be balanced with religious education based on scripture. The two-year certificate program will be offered. For the first year, this program will be offered for ladies only. Gateway medical services still sends a doctor and a nurse to the Home of Hope once weekly. Their timings are kept in a register at Home of Hope relating to hours worked, patients seen, and medicines dispensed.
