Bridges of Hope builds bridges of support between families and the community assets that can help them thrive and gain hope. The organization creates & connects partnerships between both traditional and human/social service agencies and non-traditional supports and services to assist families in resolving a crisis.

Common Goods Charity Thrift Store: Operated two thrift stores to continue mission of supporting children and families. The stores utilized ~22 volunteers (314 vol. hours) to assist in store operations and processing donations. The goal of Common Goods is to have a major impact on the number of products leaving the area and/or entering landfills. Goods are recycled and redistributed within the community, and as a result, local donations stay local and proceeds from the store help us serve local families in need.

**4b** (Code: ) (Expenses \$ 161,850 including grants of \$ 24,978) (Revenue \$ -0-)  
Resource Connection Services: assisted 1,707 households (~4,300 people) who were experiencing a financial crisis or short-term challenge or need, connecting them to viable community resources (both formal and informal programs and services), with the goal to improve family stability and wellbeing. Of those who remained in contact with us, 80% reported successfully resolving their situation, 82% reported that Bridges of Hope was helpful in explaining how to access area resources, 40% reported learning about a resource previously unknown to them, and 99% reported their overall experience working with Bridges was "Good" or "Very Good." Provided \$24,978 in assistance for 99 households when all existing resources had been exhausted.

**4c** (Code: ) (Expenses \$ 75,869 including grants of \$ 3,413) (Revenue \$ 68,600)  
Family Support Services: Offered and/or provided preventative short-term case management services for 87 at-risk families with children (~330 people), connecting them to community-based support services and empowering them to access future community supports independently, with the goal to prevent child abuse and reduce the number of families screened in to county child protective services. On average, families who completed services raised their "Family Strengths Score" by 3.72 points from when they began services (rated using our Family Strengths Assessment Tool). Provided \$4,504 in assistance for 14 households when all existing resources had been exhausted.
