ACCI sends contracted missionaries to proclaim the good news of salvation in Jesus throughout the world. These missionaries are in many countries, and perform a variety of activities, including evangelism, church planting and support, practical community help and relief, training and discipleship, etc. Many of the missionaries work with other like-minded organizations in their area of service. ACCI contracted 28 such missionaries who ministered in 10 countries in 2015.

4b (Code:) (Expenses \$ 238,977 including grants of \$) (Revenue \$)

ACCI works with other organizations to advance the Gospel of Christ throughout the world. Some of those organizations have bases of operations in countries where ACCI contracted missionaries serve, and some are local organizations that work in conjunction with ACCI contracted missionaries on common goals or projects. In 2015, ACCI provided counsel and some funding to 3 organizations that ministered in 3 different countries.

ACCI provides spiritual support and encouragement to the missionaries that it contracts with around the world. In 2015, ACCI provided such support through ongoing prayer and mentoring, some assistance with donor communications, practical planning, and strategic advice, all via Skype, email, telephone calls, and where fiscally possible, personal visits with the missionaries.

Part 1, Line 2: Adventive Cross Cultural Initiatives ("ACCI") provides funds to other Christian organizations in order to help expand ACCI's ministry goals around the world. ACCI only provides funds to organizations that demonstrate a common belief in Jesus and a common approach to ministry, as evidenced by those organizations' statements of faith and published ministry objectives. ACCI only provides funds to organizations that are registered nonprofit organizations under their home countries' laws. ACCI only provides funds to organizations with which it enters into written agreements specifying the expectations and duties of both parties. Those agreements contain requirements that the receiving organizations must report to ACCI how all funds are used, and in those agreements, ACCI maintains the right to discontinue the relationship at any time the receiving organization does not comply with the reporting requirements or if the funds are not used according to ACCI's exempt purposes. ACCI monitors the reports, and when possible, it sends representatives to visit the receiving organizations and report on how funds are being used.

Part 1, Line 3, Region 1, Column (e) and Part II, Line 1, Section (1), Column (d): ACCI is a friend of a Canadian organization that is also called Adventive Cross Cultural Initiatives. The organizations are separate, and each has an independent board of directors, but the organizations work together in many ways. Both send contracted missionaries throughout the world to promote the Gospel of Jesus Christ, & both support similar Christian organizations that share the same beliefs and ministry objectives. Both boards try to meet together, and where possible, the organizations try to utilize resources in the most efficient manner possible. ACCI-Canada sends money to ACCI-US throughout the year to support ACCI-US ministries and ACCI-US sends money to ACCI-Canada to support its ministries. (As reported elsewhere in this Form 990 & its Schedules in 2015 ACCI-Canada donated \$42,578 for its ministry projects, and ACCI-US donated \$30,808 to ACCI-Canada for its ministry projects.) These ministry projects include world-wide evangelism, church planting and support, practical physical support and relief for the poor, and support of other Christian ministries doing similar work in other countries.

Part 1, Line 3, Region 2, Column (e): In South/Central America, there are two projects in Belize and one in Ecuador. In the first Belize project, an ACCI contracted missionary pastors a church that reaches out to evangelize and disciple the Garifuna people group. Usually at least once per year, ACCI sends staff and short-term teams to assist the church in reaching the Garifuna people in the local Belizean community. The second project in Belize is the "Belize Micro Finance Project." This project utilizes small "microloans" to assist members of the church described above to start and support small businesses. These businesses help the church members earn a living and thereby support the church through contributions. The micro loans are paid back to the project, and the project can then use the repayments to fund additional businesses, thereby reducing poverty in the local (cont'd on next page)

The Belize Micro Finance Project is overseen by an advisory board made up of Belizeans and North Americans, including an ACCI Board member, and assisted by an ACCI staff member.

In Ecuador ACCI is a "friend" of orphanage and children's center. Several ACCI contracted missionaries have worked with this organization, which provides love, housing, medical assistance, education and care to orphaned, abandoned and disabled children.

Part 1, Line 3, Region 3, Column (e): In Europe/Italy ACCI has 4 different individuals managing 4 separate ministerial projects. All serve in an aspect to evangelize in their perspective communities (1 in Assisi, 2 in Parma and 1 Levanto) to promote the Gospel of Jesus Christ, offer discipleship training, and any practical physical support or relief as a means of encouragement and showing God's love through their support.

Part 1, Line 3, Region 4, Column (e): In Sub-Saharan Africa, ACCI has a contracted missionary who pastors a local church and leads a soccer ministry. The church ministers to local believers and reaches out to the community with the hope of the Gospel of Jesus Christ. The soccer ministry uses this popular sport to share the Gospel with people who might otherwise not attend the local church.

In Kenya a missionary leads a ministry that also promotes the Gospel of Christ, mentoring those in his community and offers support where needed.

Part 1, Line 3, Region 5, Column (e) and Part II, Line 3: ACCI is a "friend" of a New Zealand nonprofit organization that operates a Christian health club that is used to promote the Gospel of Jesus Christ to its members, and that uses its facilities and staff to provide Christian seminars and discipleship training in the community. Part IV, Line (1), Columns (b) and (c): Tony Hedrick was a founding member of Adventive Cross Cultural Initiatives ("ACCI") in the US and in Canada. (ACCI-US) and ACCI-Canada are separate organizations, each with an independent board of directors.) Tony served on both boards until October of 2007, and he served as Executive Director and as a missionary with both organizations until October of 2007. Tony currently serves as an ACCI-US contracted missionary, promoting and working with ACCI ministry projects in Canada, England, Norway, Italy and Slovenia. ACCI-US pays Tony for his contracted services based on donations for related projects. In 2015, Tony received \$30,568.33 from ACCI-US for his work. (All ACCI contracted missionaries, including Tony, receive monthly payments based on project donations for that month.)

Part IV, Line (2), Columns (b), (c), and (d): As noted above and in various other parts of the Form 990 and its Schedules ACCI-US and ACCI-Canada share a common history, and cooperate together in many ways, including combined ministry objectives and projects and cooperative planning and fellowship. As noted elsewhere, the two organizations financially support each others' ministries. As noted above, Tony Hedrick was a founding member of both organizations, and served on both boards as Executive Director of both organizations. Currently John Haley serves as the Executive Director of both organizations. Each organization's relationship with the other is outlined in their affiliate ministries contract, and that contract also governs transactions between the organizations. Generally, those transactions occur monthly, and involve the transfer of funds between the two organizations for ministry project support. The organizations use a book-recognition system, where donations between the two are offset, with the organization donating the greater amount actually sending the difference to the other organization, but with both organizations recording the total transfers on their books. All transactions, per the contract, must be for ministry purposes, and must be reported to each organization's respective boards.
