Community Action Project of Tulsa County Inc 's (CAP Tulsa) mission is to help young children in lower-income families grow up and achieve economic success CAP Tulsa is one of the largest anti-poverty agencies in Oklahoma and believes every family and child deserves the same opportunity for success This is achieved by empowering low-income families with the education and tools they need to break the cycle of poverty CAP Tulsa provides the support and guidance with early childhood education and comprehensive enrichment programs for the entire family CAP Tulsa specifically focuses on a two generation approach that aims not only to prepare young children for future success in school, but also their parents through programs designed to increase parenting skills, employability and earning potential The goal is that children enter school prepared for success, families create a nurturing and secure environment for their children, and families are connected to one another

Early Childhood Education Programs The early childhood program provides early education services to income eligible children Community Action Project of Tulsa County, Inc 's (CAP Tulsa) flagship program promotes early childhood education by delivering a comprehensive high-quality school readiness curriculum addressing the educational, nutritional, health, social and emotional needs of low-income children ages birth to five As the primary head start grantee for Tulsa County, CAP Tulsa presently directly operates over 138 classrooms at 12 different sites strategically located throughout the City of Tulsa and surrounding communities In 2015, we served more than 2,300 children, ages birth to five, nearly all of which are from families living at or below the federal poverty lines Additionally CAP Tulsa oversees operations with 10 partners throughout the state serving an additional 1,051 children By combining best practices in early education and collaborative partnerships with area school districts, social services agencies, and healthcare practitioners, CAP Tulsa offers a range of services targeted to children and their families These services include parental education, crisis intervention, medical and dental care, nutrition assistance, and instruction to children with special needs Our program has been identified by the U S Department of Health and Human Services as one of the most innovative in the country, and the majority of our preschool centers have achieved accreditation from the highly-regarded National Association for Education of the Young Child (NAEYC)

Family Advancement & Social Services CAP's citywide Early Childhood Program serves as the entry point for parents to simultaneously receive a variety of support services tailored to meet individualized goals for education, employment, parenting skills, social capital, health and well-being The agency's flagship example of this two-generation programming is CareerAdvance - a parent-centered work-readiness program designed by national experts that offers training and job placement in the healthcare sector exclusively to parents of young children The Family Advancement programs served 265 adults and families in 2015 Community Action Project of Tulsa County, Inc (CAP Tulsa) partners with family & children services to provide family support, parent education, crisis intervention and family counseling services CAP Tulsa also collaborates with multiple community partners to meet the health care needs of enrolled children, their parents and siblings In total, our program has collaborative agreements with more than 20 different partners and providers of various supportive services
