THE FOUNDATION PROVIDES THREE MAIN PROGRAMS: MONITORY GRANT SUPPORT, PRIMARY CARE PROVIDER DEVELOPMENT INITIATIVES, AND CAPACITY BUILDING SUPPORT. MONITORY GRANT SUPPORT SAW THE DISTRIBUTION OF \$2,017,647 TOWARD THE FINAL YEAR OF THE CLINICS OF EXCELLENCE PROJECT. THIS INITIATIVE TO ESTABLISH CHARITABLE PATIENT CENTERED MEDICAL HOMES SAW A 425% INCREASE IN AVAILABLE PATIENT CARE APPOINTMENTS AS WELL AS A CALCULATED SAVINGS IN ER VISITS OF JUST OVER \$4 MILLION (WHICH WILL INCREASE ANNUALLY). ALSO, GRANT SUPPORT IN THE AMOUNT OF \$300,000 WAS PROVIDED TO CHRISTIAN MEDICAL MINISTRIES IN INDIA, HAITI AND AFRICA. THERE WAS \$34,572 DISTRIBUTED TOWARD OUR PRIMARY CARE PROVIDER DEVELOPMENT INITIATIVES TO EDUCATE AND INSPIRE MORE THAN 600 MEDICAL AND PRE-MED STUDENTS TO CHOOSE PRIMARY CARE

PATIENTS WERE PROVIDED PRIMARY CARE VISITS, AS WELL AS SPECIALTY CARE SERVICES IN DERMATOLOGY, RHEUMATOLOGY, UROLOGY, PODIATRY AND GYNECOLOGY.
