THE OBJECTIVES OF THE VTFASN ARE TO PROMOTE MEDICAL GUIDELINES THAT CAN BE APPLIED ACROSS A VARIETY OF SPAY-NEUTER MODELS, ADVANCE THE ISSUE OF SPAY-NEUTER WITHIN THE VETERINARY COMMUNITY, AND PROVIDE CONSOLIDATED RESOURCES FOR VETERINARY PROFESSIONALS. IN 2015, THE VTFASN CONTINUED THE PROCESS OF REVISING AND PROMOTING THE EXISTING PUBLISHED MATERIALS. THE FINISHED DOCUMENT IS TO BE PUBLISHED IN MID 2016.
