	ECONOMIC POLICY - THE ECONOMIC POLICY PROGRAM INCLUDES THE ECONOMIC POLICY PROJECT, THE FINANCIAL REGULATORY REFORM INITIATIVE, THE CEO COUNCIL ON INFRASTRUCTURE FINANCING, THE IMMIGRATION TASK FORCE AND THE HOUSING AND HEALTH TASK FORCE ECONOMIC POLICY PROJECT. EVEN AFTER CONGRESS AND THE PRESIDENT HAVE DECIDED HOW MUCH THE UNITED STATES WILL SPEND EACH YEAR, THERE IS A SEPARATE LIMIT ON HOW MUCH THE COUNTRY CAN BORROW TO PAY THE BILLS. IT HAS ALREADY INCURRED. BPC ISSUES TIMELY ANALYSIS OF NEW DEVELOPMENTS RELATED TO THE DEBT LIMIT. ANOTHER ISSUE BEING ADDRESSED BY THE ECONOMIC POLICY PROJECT IS RETIREMENT SAVINGS. MILLIONS OF AMERICANS ARE APPROACHING RETIREMENT WITH INADEQUATE SAVINGS. TO ADDRESS THESE ISSUES, BPC LAUNCHED THE 20-MEMBER COMMISSION ON RETIREMENT SECURITY AND PERSONAL SAVINGS, RELEASED RECOMMENDATIONS IN 2015 DESIGNED TO IMPROVE THE U.S. RETIREMENT SYSTEM, INCLUDING SOCIAL SECURITY, DISABILITY INSURANCE, DEFINED BENEFIT PENSIONS, DEFINED CONTRIBUTION SAVINGS VEHICLES LIKE 401(K) PLANS, OTHER PERSONAL SAVINGS, AND STRATEGIES TO ENSURE LIFETIME INCOME. FINANCIAL REGULATORY REFORM INITIATIVE. IN 2014, BPC RECEIVED THE BURTON FOUNDATION'S REGULATORY INNOVATION AWARD. ACCORDING TO THE BURTON FOUNDATION, BPC'S WORK ON TOO-BIG-TO-FAIL, THE VOLCKER RULE, THE LINCOLN AMENDMENT, THE ROLE OF THE CONSUMER FINANCIAL PROTECTION BUREAU, AND FINANCIAL SERVICES REGULATION, "HAVE PROVIDED CONSTRUCTIVE AND ACTIONABLE RECOMMENDATIONS THAT HAVE BEEN LAUDED BY LAWMAKERS FROM BOTH PARTIES. IN AN ERA OF INTENSE AND OFTEN UNPRODUCTIVE PARTISANSHIP, THE WORK OF THE BIPARTISAN POLICY CENTER STANDS OUT AS WORTHY OF RECOGNITION. 2015 ALSO MARKED THE FIFTH ANNIVERSARY OF THE DODD-FRANK ACT. BPC CONTINUES TO FOCUS ON ACHIEVING A MORE RATIONAL AND EFFECTIVE FINANCIAL REGULATORY ARCHITECTURE OVER TIME. BPC HOSTS EVENTS REVIEWING WHAT HAS BEEN ACCOMPLISHED IN REGULATORY REFORM SINCE THE FINANCIAL CRISIS, WHAT CHALLENGES REMAIN, AND BPC'S RECOMMENDATIONS FOR HOW TO ADDRESS THEM. IN 2015, BPC BEGAN TO EXPLORE THE DIFFERENCES BETWEEN THE BANKING SECTOR AND THE INSURANCE SECTORS AND THE IMPACTS OF THE DODD-FRANK ACT EXECUTIVE COUNCIL ON INFRASTRUCTURE. BPC LAUNCHED THE EXECUTIVE COUNCIL ON INFRASTRUCTURE TO IDENTIFY POLICY REFORMS NEEDED TO FACILITATE PRIVATE SECTOR INVESTMENT IN U.S. INFRASTRUCTURE. TO INFORM THIS WORK, THE COUNCIL HOSTED PUBLIC EVENTS, RELEASED MODEL LEGISLATION FOR STATE GOVERNMENTS TO BROADLY ENABLE PUBLIC-PRIVATE PARTNERSHIPS, PUBLISHED OP-EDS AND BLOG POSTS, DEVELOPED A SERIES OF INSTRUCTIVE CASE STUDIES WITH LESSONS LEARNED, AND DELIBERATED ON POTENTIAL RECOMMENDATIONS IN COUNCIL MEETINGS AND CONFERENCE CALLS. THROUGH RESEARCH AND STAKEHOLDER OUTREACH, THE COUNCIL HAS EXPLORED HOW TO ADDRESS SOME OF THE RISKS INHERENT IN DEVELOPING AND INVESTING IN U.S. INFRASTRUCTURE - INCLUDING PERMITTING RISK, PIPELINE RISK AND POLITICAL RISK. IT IS THE COUNCIL'S INTENTION TO USE THIS RESEARCH AND HELPFUL INPUT TO FORMALIZE A REPORT IN 2016 WITH ACTIONABLE RECOMMENDATIONS TO ALL LEVELS OF GOVERNMENT. IMMIGRATION TASK FORCE. IN 2015, THE IMMIGRATION TASK FORCE SET OUT TO MAKE A CASE FOR IMMIGRATION REFORM THROUGH A RESPONSIVE RESEARCH AGENDA AND PUBLIC AND PRIVATE EVENTS WITH KEY STAKEHOLDERS. THE TASK FORCE AND STAFF PRODUCED OBJECTIVE, FACT-ORIENTED ANALYSIS ON CRITICAL IMMIGRATION ISSUES THROUGH SEVERAL REPORTS AND DOZENS OF BLOG POSTS AND ISSUE BRIEFS. BUILDING ON PAST ECONOMIC ANALYSIS, THE TASK FORCE PARTNERED WITH OUTSIDE CONSULTANTS TO RESEARCH, PRODUCE AND RELEASE A MAJOR REPORT ON THE MACROECONOMIC AND BUDGETARY EFFECTS OF SEQUENCED ("STEP-BY-STEP") LEGISLATIVE REFORM. WE ALSO RELEASED SEVERAL ISSUES BRIEFS AND BLOGS ON THE HOTLY-DEBATED ISSUES OF IMMIGRATION'S IMPACT ON THE LABOR FORCE IN AN EFFORT TO BRIDGE THE GAP BETWEEN COMPETING UNDERSTANDINGS OF THOSE EFFECTS. IN OVER 25 BLOG POSTS THROUGHOUT THE YEAR, THE STAFF ALSO TACKLED A WIDE RANGE OF TOPICS, INCLUDING BORDER SECURITY AND ENFORCEMENT, SANCTUARY CITIES, THE REFUGEE CRISIS, THE CONTINUING INFLUX AT THE BORDER OF CENTRAL AMERICAN CHILDREN AND FAMILIES, THE PRESIDENT'S IMMIGRATION EXECUTIVE ACTIONS, AND MANY OTHERS. HOUSING AND HEALTH. OUR NATION IS GROWING OLDER. THE NUMBER OF AMERICANS AGED 65 OR OLDER WILL RISE FROM 35 MILLION IN 2000 TO NEARLY 73 MILLION IN 2030. FURTHER, THE NUMBER OF AMERICANS NEEDING SERVICES AND SUPPORTS IN EXPECTED TO MORE THAN DOUBLE OVER THE NEXT 40 YEARS. COMPLICATING THIS SITUATION IS THE FACT THAT HOUSING AFFORDABILITY IS A SERIOUS PROBLEM FOR MANY SENIORS. BPC LAUNCHED THE HOUSING AND HEALTH TASK FORCE IN 2015 TO DEVELOP RECOMMENDATIONS TO ADDRESS THESE NEEDS.
