<p>PUBLIC SERVICEUNIVERSALGIVING HELPS ORGANIZATIONS AROUND THE WORLD ACCESS RESOURCES BY CONNECTING DONORS AND VOLUNTEERS TO VETTED NGOS AND THEIR PROJECTS IN AN EFFICIENT AND TRANSPARENT MANNER. UNIVERSALGIVING'S WEBSITE (WWW.UNIVERSALGIVING.ORG) PROVIDES A FREE PUBLIC SERVICE WHERE USERS CAN SELECT AMONG HUNDREDS OF VOLUNTEER AND DONATION OPPORTUNITIES TO HELP PEOPLE IN NEED, SUCH AS VOLUNTEERING TO BUILD SCHOOLS IN NEPAL OR MAKING A \$10 DONATION TO PROVIDE MOSQUITO NETS TO FAMILIES IN CAMEROON. UNIVERSALGIVING DOES NOT TAKE A CUT, SO 100% OF EVERY DONATION MADE TO OUR PARTNER NGOS GOES DIRECTLY TO THE CAUSE. WE WANT OUR SERVICE TO BE FREE TO THE PUBLIC AND IT HAS BEEN SINCE WE BEGAN IN 2002. CRITICAL TO OUR MISSION IS OUR VOLUNTEERING SERVICE. WE HELP VOLUNTEERS IN MORE THAN 100 COUNTRIES, WHICH HAS INCREASED 20% SINCE LAST YEAR. FOR EXAMPLE, WE MATCHED ONE VOLUNTEER WITH THE OPPORTUNITY TO SPEND THE SUMMER IN POLAND WITH WORLDTTEACH. ANOTHER VOLUNTEER BUILT A HEALTH CLINIC IN KENYA WITH THE GLOBAL CITIZENS NETWORK. IN 2015, UNIVERSALGIVING FACILITATED MORE THAN 3,146 VOLUNTEER REFERRALS, OUR HIGHEST NUMBER TO DATE. IN TOTAL, WE HAVE EMPOWERED MORE THAN 27,568 VOLUNTEERS TO HELP WITH PROJECTS FOR COMMUNITIES IN NEED ALL OVER THE WORLD. STUDENTS, FAMILIES, AND RETIREES USE UNIVERSALGIVING TO FIND MEANINGFUL TRIPS THAT SERVE THE IMPOVERISHED. JUST THIS YEAR ALONE WE HAVE FACILITATED MORE THAN \$5,033,600 WORTH OF VOLUNTEER HOURS CONTRIBUTED. IF ONE VALUES THE VOLUNTEER'S HOUR AT \$20 PER INDEPENDENT SECTOR, AND A TRIP IS ON AVERAGE TWO WEEKS, WE HAVE FACILITATED MORE THAN 36 MILLION WORTH OF VOLUNTEER HOURS. THIS IS AN EXTREMELY CONSERVATIVE ESTIMATE, SINCE MANY OF OUR VOLUNTEERS VOLUNTEER FOR MONTHS OR EVEN YEARS AT A TIME. UNIVERSALGIVING VETS EACH NON-PROFIT NGO ON OUR WEBSITE WITH OUR QUALITY MODEL, A RIGOROUS 24 STAGE PROCESS, ENSURING THAT OUR USERS CAN GIVE AND VOLUNTEER WITH A TRUSTED, QUALITY ORGANIZATION. UNIVERSALGIVING SERVES NUMEROUS, DIVERSE DONORS AND VOLUNTEERS OF ALL AGES, BACKGROUNDS, AND ECONOMIC STATUS. UNIVERSALGIVING HAS BEEN FEATURED ON CBS NEWS, OPRAH.COM, THE CHRONICLE OF PHILANTHROPY, MOTHER JONES, CNNMONEY, AND BUSINESSWEEK. JUST THIS YEAR, WE CLOSED A NEW PARTNERSHIP WITH FORBES WHERE WE PUBLISH ARTICLES AND LINKS TO OUR NGO TWICE MONTHLY, A SIGNIFICANT PARTNERSHIP THAT PROMOTES OUR NGOS. WE WERE ALSO PUBLISHED WITH ARTICLES ABOUT OUR NGOS ON TRIPLE PUNDIT, GLASS CEILING, FORBES, CHRISTIAN SCIENCE MONITOR, COMMUNITY BASED JOURNALISM AND DEAR PAMELA. UNIVERSALGIVING HAS FACILITATED NEARLY \$2 MILLION IN SMALL, MICRO DONATIONS, MUCH OF IT FROM SMALL DONATIONS OF \$5 TO \$15. WE WANT TO MAKE GIVING ACCESSIBLE TO PEOPLE OF ALL AGES AND INCOMES. 100% OF EVERY DONATION GOES DIRECT TO THE CAUSE. IN 2015, 275 DONORS GAVE A TOTAL OF \$155,063.00. UNIVERSALGIVING IS VERY POPULAR FOR GIVING DONATIONS FOR CRISIS EVENTS, SUCH AS PROVIDING RELIEF TO THE VICTIMS OF THE NEPAL EARTHQUAKE AND HELP AID SYRIAN REFUGEES. PEOPLE ALSO USE OUR FUNDRAISING PAGE TO RAISE FUNDS FOR THEIR FAVORITE CAUSE, FOR HOLIDAYS, ANNIVERSARIES, CELEBRATIONS, TOURNAMENTS, GIFT REGISTRIES, AND WALK-A-THONS. AS PART OF UNIVERSALGIVING'S PUBLIC SERVICE, WE HAVE A DONATE FEATURE ON OUR WEBSITE THAT ALLOWS VISITORS TO GIVE A TIP TO UNIVERSALGIVING TO SUPPORT OUR WORK SERVING PEOPLE AROUND THE WORLD. ALMOST 40% OF ALL DONORS CHOSE TO SUPPORT UNIVERSALGIVING IN THE FORM OF A SMALL TIP, TYPICALLY \$15, WHEN THEY VISITED OUR WEBSITE. THEY DO SO BECAUSE THEY SUPPORT OUR FREE SERVICE, HELPING PEOPLE GIVE AND VOLUNTEER IN MORE THAN 100 COUNTRIES. ONE OF UNIVERSALGIVING'S KEY SERVICES IS TO HELP PROVIDE RELIEF TO CRISIS STRICKEN COUNTRIES. WE SUPPORT SMALL, TOP-PERFORMING NGOS WHO SIGNIFICANTLY IMPACT THEIR COMMUNITIES, BUT ARE THEMSELVES LARGELY UNKNOWN. WE HAVE 200 PUBLISHED ORGANIZATIONS ON THE SITE WHO WORK IN 80 COUNTRIES AND TERRITORIES IN THE AREAS OF HEALTH, EDUCATION AND TECHNOLOGY, WAR PREVENTION, ANIMAL RIGHTS, POVERTY ALLEVIATION, COMMUNITY AND ECONOMIC DEVELOPMENT, ENVIRONMENTAL PROTECTION AND SUSTAINABILITY, AND DISASTER RELIEF. OUR TOP NGO PARTNERS FOR 2015 WERE INTERNATIONAL MEDICAL CORPS, DEVELOP AFRICA, EMBRACE, AND THE GVN FOUNDATION. INTERNATIONAL MEDICAL CORPS IS A GLOBAL, HUMANITARIAN, NONPROFIT ORGANIZATION DEDICATED TO SAVING LIVES AND RELIEVING SUFFERING THROUGH HEALTH CARE TRAINING AND RELIEF AND DEVELOPMENT PROGRAMS. THEIR MISSION IS TO IMPROVE THE QUALITY OF LIFE THROUGH HEALTH INTERVENTIONS AND RELATED ACTIVITIES THAT BUILD LOCAL CAPACITY IN UNDERSERVED COMMUNITIES WORLDWIDE. BY OFFERING TRAINING AND HEALTH CARE TO LOCAL POPULATIONS AND MEDICAL ASSISTANCE TO PEOPLE AT HIGHEST RISK, AND WITH THE FLEXIBILITY TO RESPOND RAPIDLY TO EMERGENCY SITUATIONS, INTERNATIONAL MEDICAL CORPS REHABILITATES DEVASTATED HEALTH CARE SYSTEMS AND HELPS BRING THEM BACK TO SELF-RELIANCE. THEY RECEIVED \$1,350 IN DONATIONS FROM UNIVERSALGIVING. DEVELOP AFRICA FACILITATES SUSTAINABLE DEVELOPMENT PROGRAMS ACROSS 6 AFRICAN COUNTRIES. THEY FOCUS ON CAPACITY BUILDING, TECHNOLOGY, AND EDUCATION. THEIR PROJECTS INCLUDE PROVIDED SOLAR-POWERED RUNNING WATER AND BOOKS TO CHILDREN IN NEED. IN 2015, DEVELOP AFRICA RECEIVED \$6,210 IN DONATIONS AND 6 VOLUNTEER REFERRALS FROM UNIVERSALGIVING. SITE EMBRACE IS A NONPROFIT ORGANIZATION DEDICATED TO SAVING THE LIVES OF PREMATURE AND LOW BIRTH WEIGHT BABIES IN THE DEVELOPING WORLD. THE AWARD-WINNING EMBRACE WARMER COSTS THE FRACTION OF A PRICE OF AN INCUBATOR, DOESN'T REQUIRE CONSTANT ELECTRICITY, AND IS PORTABLE, HYGIENIC AND REUSABLE. THE TRAINING AND EDUCATION PROGRAMS HELP HEALTH CARE WORKERS AND MOTHERS PREVENT HYPOTHERMIA AND CARE FOR PREMATURE INFANTS. EMBRACE RECEIVED \$2,500 IN DONATIONS AND 3 REFERRALS FROM UNIVERSALGIVING. THE GVN FOUNDATION SUPPORTS LOCAL COMMUNITY ORGANIZATIONS IN VARIOUS COUNTRIES THROUGH ORGANIZING VOLUNTEER TRIPS AS WELL AS THROUGH THE DISTRIBUTION OF FINANCIAL, IN-KIND, AND MATERIAL DONATIONS. ONE OF THE MOST POPULAR VOLUNTEER OPPORTUNITIES THE GVN FOUNDATION OFFERS ON UNIVERSALGIVING IS VOLUNTEERING WITH CHILDREN IN THE PHILIPPINES. VOLUNTEERS HELP COMMUNITY EFFORTS TO PROVIDE NUTRITION, HOUSING, EDUCATION, HEALTH CARE, AND OTHER SERVICES TO SURVIVORS OF TYPHOON HAIYAN. GLOBAL CITIZENS NETWORK PROMOTES CROSS-CULTURAL UNDERSTANDING AND INTERCONNECTEDNESS THROUGH INTERNATIONAL IMMERSION EXPERIENCES. SMALL GROUPS OF VOLUNTEERS LIVE AND WORK IN SMALL VILLAGES, WHERE THEY EXPERIENCE A NEW CULTURE AND BUILD RELATIONSHIPS. IN 2015, GCN RECEIVED 406 VOLUNTEER REFERRALS FROM THE UNIVERSALGIVING WEBSITE.</p>

<p>MAJOR PARTNERSHIPSPUBLIC SERVICE UNIVERSEALGIVING PARTNERS WITH OTHER ORGANIZATIONS IN SUPPORT OF UNIVERSALGIVING'S MISSION TO INCREASE GIVING AND VOLUNTEERING BY PROMOTING OUR VETTED NGO PARTNERS AND THEIR PROJECTS. WE ARE EXPANDING THE REACH OF OUR NGO PARTNERS AND THEIR DESERVING CAUSES BY BUILDING RELATIONSHIPS WITH INDIVIDUAL PHILANTHROPISTS, CORPORATIONS AND FOUNDATIONS THAT SHARE OUR GOAL OF HELPING PEOPLE AROUND THE WORLD. SOME PARTNERSHIPS FROM 2015 INCLUDE COMPASS PARTNERS, SOCAP, GROUNDWORK OPPORTUNITIES, WOMEN 2.0, CHRISTIAN SCIENCE MONITOR, AND AMAZON SMILE. OTHER PARTNERSHIPS INCLUDE SOCIAL INERTIA/ACTION, WITH WHOM WE HELPED TO CREATE A MOBILE APPLICATION AVAILABLE TO OVER 100 NONPROFITS FEATURING WAYS TO GIVE, VOLUNTEER, SIGN PETITIONS, AND TAKE GLOBAL ACTION. UNIVERSALGIVING ALSO WORKED WITH SYNERGOS, A GROUP OF HIGH NET WORTH DONORS HELPING THEM GIVE BACK TO SOCIETY IN MORE THAN 40 COUNTRIES ACROSS THE WORLD. ALL OF THESE PARTNERSHIPS ARE BRINGING NEW DONORS AND VOLUNTEERS TO HUNDREDS OF OUR NGO PARTNERS. WE PIONEER NEW INNOVATIVE WAYS TO HELP, SUCH AS COMMUNITY BASED JOURNALISM WHERE WE PARTNER WITH MEDIA ORGANIZATIONS TO INCREASE GIVING AND VOLUNTEERING. FOR EXAMPLE, CHRISTIAN SCIENCE MONITOR IS ONE OF OUR TOP COMMUNITY BASED JOURNALISM PARTNERS THROUGH THEIR "PEOPLE MAKING A DIFFERENCE" ARTICLES. AFTER SOMEONE IS INSPIRED BY READING AN ARTICLE OR WATCHING A VIDEO ABOUT PHILANTHROPY, A LINK IS PROVIDED FOR THEM TO GIVE AND VOLUNTEER ON UNIVERSALGIVING. FOR EXAMPLE, AFTER THEY READ AN ARTICLE ABOUT A CRISIS IN THAILAND, THEY CAN THEN TAKE ACTION THROUGH UNIVERSALGIVING AND DONATE OR VOLUNTEER WITH ONE OF OUR NGO PARTNERS IN THAILAND. COMMUNITY BASED JOURNALISM PARTNERSHIPS PROMOTE HUNDREDS OF OUR NGO PARTNERS, MAKING THOUSANDS OF PEOPLE MORE AWARE OF THEIR DESERVING CAUSES. THOUSANDS OF PEOPLE ALSO TAKE ACTION AND GIVE OR VOLUNTEER, ALSO INCREASING THE ORGANIZATIONAL CAPACITY OF OUR PARTNERS. WE ALSO WORK WITH OTHER ORGANIZATIONS AND EVENTS, HELPING THEM PROMOTE AND FACILITATE GIVING THROUGH PUBLIC SPEAKING EVENTS AS WELL AS NUMEROUS WRITINGS ABOUT PHILANTHROPY AND COMMUNITY SERVICE. UNIVERSALGIVING FURTHERS ITS MISSION AND HELPS OUR INDUSTRY AND THE PHILANTHROPIC COMMUNITY. OUR CEO, PAMELA HAWLEY, SPOKE AND WROTE ON SOCIAL RESPONSIBILITY AT MANY EVENTS AND VENUES INCLUDING SOCAP WHERE SHE DISCUSSED THE DIFFERENT WAYS TO CREATE A PHENOMENAL GIVING EXPERIENCE, POINTS OF LIGHT CONFERENCE, PRESENTING A VARIETY OF OPTIONS FOR BUILDING CAPACITY THROUGH VOLUNTEERS, SPECIFICALLY SKILLS-BASED VOLUNTEERING. THIS NETWORK OF NONPROFITS AND SOCIAL ENTREPRENEURS ALLOWS ITS MEMBER TO COLLOCATE, COLLABORATE, AND INCREASE THEIR IMPACT FOR SOCIAL GOOD. PAMELA WRITES DAILY ON TOPICS OF GLOBAL PHILANTHROPY AND SOCIAL RESPONSIBILITY FOR PUBLICATIONS AND ORGANIZATIONS SUCH AS SEECHANGE MAGAZINE, FAST COMPANY, AND CSRWIRE.
