WE ALSO SERVE FAMILIES ACROSS THE SOCIOECONOMIC SPECTRUM. APPROXIMATELY 25% OF OUR CHILDREN HAVE A DISABILITY OR ARE CONSIDERED AT HIGH RISK. THIRTY-FIVE PERCENT (35%) OF OUR FAMILIES RECEIVE TUITION SUBSIDIES. IN 2015, WE SERVED OVER 300 CHILDREN AND THEIR FAMILIES.
