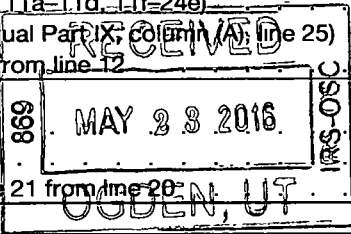

Rehabilitation of injured/sick sea turtles. Care and placement of non-releasable turtles. Healthy sea turtles are released back into the wild. Non-releasable sea turtles are used for educational purposes. In 2015 we had 149 sea turtle stranded. Of these 96 were live and 86 were dead. 52 sea turtles were released in 2015 - 7 were determined to be non-releasable.

Conservation - support of sea turtle conservation efforts worldwide. Sponsor of local (South Padre Island and Boca Chica Beach) beach patrols and South Padre Island corral for protection of sea turtle nests and eggs. In 2015, 36 nests were recovered (3248 eggs.) There were 2442 hatchlings released with 7 public releases. last there summer there were 9 interns

Educational presentations to school groups and public to inform them of the endangered status of sea turtles and how to support conservation efforts. In 2015 there were approximately 125,000 visitors to the facility. There were field trips both to the facility and a new feature - virtual field trips. Last summer's Kid's camp had 60 participants.
