LEGAL ADVOCACY PROGRAM (LAP)AVDA's legal advocacy program is the primary source of free legal representation for low and moderate-income victims of family violence in cases pending in harris county family courts AVDA serves as attorney of record in lawsuits to safeguard victims from further abuse (protective orders, kick-out orders, terminating the parental rights of child molesters) and to dissolve the legal ties that bind a victim to his/her Abuser (divorce, suits affecting the parent-child relationship) In 2015, AVDA's seven attorneys litigated cases that directly impacted the safety, legal rights, and financial stability of numerous victims, and the agency assisted almost 3,500 victims of abuse and their children through the legal process
