THE BOARD DECIDES EACH YEAR THAT THE PERCENTAGE IS PRUDENT BASED ON ECONOMIC CONDITIONS AND MAY DECIDE TO ADJUST THE DISTRIBUTION TO A LESSER AMOUNT. IN ESTABLISHING THIS POLICY, THE FOUNDATION CONSIDERED THE LONG-TERM EXPECTED RETURN ON ITS ENDOWMENT. ACCORDINGLY, OVER THE LONG TERM, THE FOUNDATION EXPECTS THE CURRENT SPENDING POLICY TO ALLOW ITS ENDOWMENT TO GROW OVER TIME.
