EMI is a technical resource for other mission organizations around the world, both in development and disaster relief contexts In 2015, EMI worked on 72 projects in 23 countries, sending out teams that totaled 163 volunteers and 43 interns These projects represent design work that will enable the construction of hospitals, schools, orphanages, water pipelines, ministry centers, youth camps, churches and places to live for some of the poorest people in the hardest to reach corners of the world From evaluating buildings damaged by the Nepal Earthquake, to designing hospitals in Kenya and Burundi, to working on community water systems in the Democratic Republic of Congo - EMI teams provided technical and strategic design assistance to many clients in a variety of critical times and places
