Imagine Enterprises is a Financial Management Services Agency (FMSA) for the HOME AND COMMUNITY SERVICES [HCS] and TEXAS HOME LIVING [TXHmLVG] MEDICAID waivers providing fiscal agent services that support 207 individual employers. When a person receives a Texas Medicaid Waiver there are two ways to receive services - either through a provider agency or the Consumer Directed Services (CDS) option. Choosing the CDS option allows the Medicaid recipient, their family or guardian to self-direct by becoming an employer and hiring their own staff. Financial Management Services include payroll, reporting quarterly taxes, monthly usage reports, producing W-2's, and background checks for every employee.
