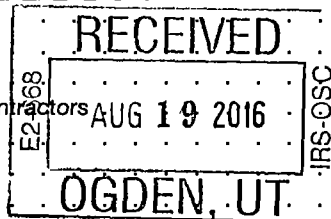

After completing projects of infrastructure (housing, water, sewer, electricity and school) the principal activity of Austin Helps Honduras continues to be support of scholarships for children of Colonia Solidaridad, the village constructed (beginning in 1999) to relocate flood victims of Hurricane Mitch (1998).

Line 10 - Amounts paid include scholarships offered to all children of Colonia Solidaridad who need economic assistance for school uniforms shoes, school supplies and incidental expenses, especially those who are able to attend school beyond the government provided 6th grade - to include college. Candidates are screened and recommended by a committee of Honduran agents (Juan Pablo Aguilera and Mary A. Owen) then finally approved by a US committee of sponsors. Students are re-approved each semester only if they have passing grades. Also some economic assistance is provided for a few adults for short term vocational training.

Line 16 - Other expenses include bank charges, international banking transfe fees and lap top.

Austin Helps Honduras has never received support from a government unit.
