CHARITABLE GIVING: 501 (c) (3) organizations operating in each of Grande Communications' markets (all within Texas) are invited to submit grant applications to the Grande Cares committee in each market. Based on the grant money allocated to each market each quarter, the market-level committee decides which organizations they would like to give to. Their recommendations are then voted on by the entire Grande Cares board of directors each quarter. In 2015, fifty-four grants were approved for an average grant amount of \$1,756. The applications ask the organization to describe their mission or purpose and their target beneficiaries. Typically, the local committee makes a visit to the organization to see first-hand how the group operates. The number of grants per market in 2015 were Austin (9), San Antonio (9), Dallas (6), Waco (9), Midland/Odessa (5), Corpus Christi (7), and San Marcos (9).

VALUED VOLUNTEER GRANTS: Grande Cares members can donate their time to local non-profit organizations and after they accumulate a certain amount of hours, the member can request either \$200 or \$400 be paid to the non-profit organization. In 2015, twenty-six valued volunteer grants were approved for an average grant amount of \$369. The number of grants per market in 2015 were Dallas (1), San Antonio (4), San Marcos (8), and Waco (13).

GRANDE EMPLOYEE MEMORIAL SCHOLARSHIP GRANTS: Each year, The Grande Cares organization awards scholarships to one or more students for their post-secondary education. Potential scholarship awardees are asked to complete an application which is reviewed and voted on by a scholarship subcommittee of Grande Cares. In 2015, eight scholarships were awarded for an average amount of \$563. The number of grants per market in 2015 were Austin (1), Dallas (3), Midland/Odessa (2), and San Marcos (2).
