THE BRIDWELL CENTER FOR EMERGENCY CARE PROJECT IS AN EXPANSION AND RENOVATION OF UNITED REGIONAL'S CURRENT EMERGENCY DEPARTMENT (ED) WHICH WAS BUILT IN 1999 TO ACCOMMODATE APPROXIMATELY 37,000 ANNUAL VISITS. SINCE THAT TIME, THE NUMBER OF ANNUAL PATIENT VISITS HAS MORE THAN DOUBLED. WHEN THE PROJECT IS COMPLETE, THE BRIDWELL CENTER FOR EMERGENCY CARE WILL BE TWICE THE SIZE OF THE ORIGINAL ED GOING FROM 21,000 SQ. FT. TO 42,000 SQ. FT. RENOVATING AND ENLARGING UNITED REGIONAL'S ED WILL FURTHER EXPAND THE QUALITY OF CARE FOR PATIENTS BY PROVIDING MORE TREATMENT AREAS AND HELP REDUCE WAIT TIMES, ENHANCING SERVICE TO PATIENTS AND FAMILIES.
