Arlington Urban Ministries serves clients who are homeless, exited from homeless and battered women's shelters, sick, elderly, unemployed and the working poor. In 2015 Arlington Urban Ministries served 800 clients.

NU2U is a retail thrift shop that sells gently used clothing at greatly reduced prices.
