As a 501(c)(3) nonprofit organization, we partner with churches and other organizations to perform research, offer Biblical worldview training, and affect public policy both in the legislature and the courts. Highlights for 2015 include survey research on school choice, religious freedom, life issues and traditional marriage. Specifically, we undertook large research and polling projects to determine the extent of research in the state using aborted fetal tissue. Results were shared with the press and policy makers. Additionally, we serve as a resource to legislators and other policy makers for data and statistics in all of the policy arenas mentioned above.
