Sotera House provides a safe, non-coercive, home like environment for those diagnosed with serious mental illness to recover from long-term symptoms Sotera-House is an effective alternative to hospitalization In April/May of 2015 the Board of Directors decided to close Sotera House Residents were notified of the closure on June 1,2015 Intensive Case Management staff assisted residents to find new assisted living facilities and the last resident moved out on July 15, 2015 The leased property was returned to the landlord on August 31, 2015 Final payments and resolution of all issues with the landlord were resolved by May 2016

CHOICES, Inc implemented the Housing First Assertive Community Treatment (ACT) Team. This is a trans-disciplinary team of service providers which provide client-centered treatment to address serious mental illness and dual diagnosis disorders. It is a client centered, recovery-oriented behavioral health service to reduce psychiatric hospitalization, stabilize community integration and enhance overall recovery. It is comprised of a clinical team leader, a psychiatric prescriber, registered nurses, mental health clinicians, a substance abuse specialist, a vocational specialist, a peer specialist, a housing specialist, and a program assistant
