These awards are governed by grant agreements between Alfanar, Inc., US and Alfanar which were approved on February 09, 2015

and August 21, 2015 at two Board meetings held on the mentioned dates. The disbursed grants were sent exclusively for charitable or educational purposes as defined under Internal Revenue Code 501 (c) 3. Grant funding deployed to Alfanar is used for general purposes and operations that further Alfanar's venture philanthropy work in Egypt and Lebanon. \$3,164 of the above-mentioned grants originated from the Global Fund for Widows (New York based Private Foundation) and was restricted to the Future Eve Foundation (Egypt) to support the Alfanar funded 'Amal project' which aims to financially empower widows and female heads of households in Minya, Egypt through the provision of vocational training and micro-loans.

Alfanar, Inc., US Director, Cynthia Oakes visited Egypt in February 2015 to visit Alfanar investments, including the aforementioned Future Eve Foundation. Oakes witnessed the direct of impact of Alfanar, Inc., US's grants to Alfanar and was able to assess the professionalism of Alfanar's work and lasting social impact created through the projects it supports.

Alfanar, Inc., US hosted a reception in New York on 20 October 2015, with the aim of building a US-based network of supporters of Alfanar's venture philanthropy approach. The event was held at the Century Association in Manhattan and was attended by about 80 people. Alfanar's Executive Director, Myrna Atallah, Board Chair, Lubna S. Olayan, and guest investee speaker Amina Kleit of the Ana Aqra Association based in Lebanon, gave speeches highlighting Alfanar's philanthropic work in Egypt and Lebanon.

In 2016, Alfanar, Inc., US aims to secure increasing levels of public interest and support for Alfanar's ambitious venture philanthropy program. Thus far, 2016 has seen \$300,000 in grants disbursed to Alfanar and the acceptance of Alfanar, Inc., US's trademark application to the United States Trademark and Patent Office.
