Caring Adoptions maintains a cost accounting system that enables it to track Adoptive Family Fees and assistance to Birthmothers who are in the process of making an adoption plan.

Birthmother assistance is based on an agreement negotiated between Caring Adoptions and the Birthmother detailing expenses required during the pregnancy and in most instances up to 6 weeks after placement. This agreement is presented by the Agency to the prospective Adoptive Family who has the choice to accept, renegotiate or reject the agreement. The Birthmother assistance must be within the parameters allowed by the Standards of the Texas Department of Family and Protective Services. In most instances housing, medical, legal and utility assistance are paid directly to the service provider. Food, clothing, transportation and other allowances are normally paid directly to the Birthmother on a weekly or bi-weekly basis depending on her responsible use of the funds.
