Over the years, TLR has succeeded in increasing public awareness of key issues and of advocating for changes in legislation that benefit all citizens. Numerous legal reforms advocated by TLR have been enacted into law since TLR's formation in 1994 and TLR has engaged in public debate concerning legal issues, having gained recognition as an organization that is a major contributor to public policy discussion, formation and implementation in Texas.
