Foresight's Vision Weekends and Workshops feature candid, accessible discussions with leading thinkers on the future of emerging technologies. In 2015 Foresight held the Atomic Precision for Medical Applications Workshop. This conference featured several dozen leading scientists and technologists speaking on a variety of nanotechnology related developments, research and visions. Public outreach efforts include lectures understandable by general audiences as well as specialists. Focus areas for 2015 included the development and application of molecular manufacturing and transformative nanotechnologies.
