EducationThe organization addresses the Latino student achievement gap. It pursues partnerships with other foundations and corporations, as well as business, education, and community leaders to address the low enrollment and graduation rates of Latino students in the fields of science, technology, engineering, and math (STEM). Projects include the Elevate [Math] and Elevate [Math] Plus. Over 1,800 students benefited from this program. The Parent Education Academy (PEA) program is directed toward helping Hispanic parents learn skills to guide and mentor their children to achieve academic success. Specifically, graduation from both high school and college. This program is offered to complement HFSV's STEM programs for middle school students to excel in math and get on the track to college. Over 500 Latino parents graduated FROM the PEA program.

Convening & EngagingConvening and engaging the community for the betterment of Silicon Valley Latinos is one of the Hispanic Foundation of Silicon Valley's (HFSV) three pillar priorities. The time has come to convene and engage high-tech leadership around a comprehensive and impactful initiative. To do just that, the HFSV is proposing the Latinos in Technology Initiative (LITI). LITI will be comprised of two components. The Family College Success Center (FCSC) was designed and funded. The FCSC is a resource hub which will increase educational opportunities for low-income at-risk students and their families. The FCSC is the first center of its kind in the region, if not the state. It will be a "one-start-shop" for college aspiring middle and high school students, and their parents, to obtain college access information, advice, academic enrichment, workshops, and online resources. The Latinos in Technology Scholarship (LITS) will provide up to 100 scholarships annually for five (5) years to incoming Latino college juniors who have chosen a STEM (science, technology, engineering, math) related major. Additionally, sponsoring corporate investors will provide summer internships to the scholarship recipients.

LeadershipThe organization develops Latino nonprofit leaders. The organization's Latino Board Leadership Academy (LBLA) is a comprehensive program designed to recruit and train professional Latinos to serve as potential board members in non-profit organizations that best match their personal interests. Over 70 Latinos graduated from two LBLA's offered this year.
