

testing/visual inspection. Programs are developed based on needs of the women and families in the communities where these midwives are located. These health workers use the education they receive to plan programs in their home communities. The project continues to work with 65 traditional midwives and community health workers from five municipalities in Matagalpa, Nicaragua. During 2015, the focus was on providing additional education on dental health especially for children and pregnant women, pap screening and visual inspection with acetic acid, and the identification and prevention of family and community violence. Two workshops were held on dental health and cervical cancer screening with 25 people attending each session; three additional sessions are planned in 2016. Fifty people also attended two 2-day workshops, approximately 6 weeks apart, Alternatives to Violence. The third 2-day workshop is scheduled for 2016. Since these workshops, several abused women and children have been identified by the health workers; sixteen have been accompanied through the medical, psychological and legal system related to the abuse/violence. The project works not only with the Ministry of Health, but also the Ministry of the Economy (to help the abused women and the unpaid health workers find a "cottage" industry to support themselves), ProNica, Quakers Managua (which helps to support the Alternative to Violence program), the local Casas Maternas, and other local organizations.
